

North American Saxophone Alliance 2020 High School Solo Competition

March 8, 2020 – Arizona State University

1st Prize

\$750 in cash and/or merchandise

2nd Prize

\$500 in cash and/or merchandise

3rd Prize

\$250 in cash and/or merchandise

The First Place Prizewinner will be featured on the Winners' recital at the 2020 NASA Biennial Conference in Tempe, AZ.

I. Eligibility

- 1.) Contestants must be no older than 18 years of age on March 8, 2020.
- 2.) All contestants must NOT be enrolled full-time in a college, university or other post-secondary school.
- 3.) All contestants must be current members of the North American Saxophone Alliance (NASA) as of December 15, 2019.

II. Application Guidelines

- 1.) All application materials must be submitted online via the Acceptd application system (<https://getacceptd.com/>). The deadline for submission of applications, **video recordings**, and fees is: DECEMBER 15, 2019. A direct link to the application will be provided as soon as it is made available.
- 2.) Contestants must submit an entry fee of \$40. All payments must be made through the online application by December 15, 2019.
- 3.) Incomplete applications will not be considered.
- 4.) The contestant's birth date must be verified at the competition site with the contestant's driver's license, birth certificate, or passport. Any contestant who does not show proof of age, or is older than 18 years of age as of March 8, 2020, will be disqualified.
- 5.) There are two rounds of the NASA High School Solo Competition: a recorded Preliminary Round and a live Final Round. The deadline for the recorded Preliminary Round is December 15, 2019. The live Final Round will be held as

part of the NASA Biennial Conference on March 8, 2020, at Arizona State University.

6.) Due to the logistical difficulties of preparing facilities, dates listed in the application for Final Rounds and Winners Recitals are subject to slight change.

III. Preliminary Round

THE PRELIMINARY ROUND WILL CONSIST OF A RECORDED **VIDEO AUDITION. AUDIO AND VIDEO COMPONENTS OF THE RECORDING MUST BE UNEDITED**, and all recordings must be submitted on Acceptd with the initial application materials by the deadline, December 15, 2019. The recorded music must be with live piano accompaniment. Digital versions of piano accompaniments such as smart music or music-minus-one play-a-long formats are not acceptable. For all videos submitted, all performers must be clearly visible at all times. Technical guidelines for the recordings will be posted when the Acceptd application webpage becomes available. The recording should contain a complete performance, with live piano accompaniment of:

1. *Sonata, Op. 19* by Paul Creston, **Movements 1 and 2 only** (The two movements may be recorded separately.)

IV. Final Round

Up to 12 saxophonists will be invited to perform in the final round. The Finals will be held on March 8, 2020 in conjunction with the 2020 North American Saxophone Alliance Biennial Conference in Tempe. Each finalist will be required to play the following:

1. *Concerto* by Pierre-Max Dubois, **Movement 1 only**
2. Additional music of the performer's choice. This music may be composed for any saxophone (soprano, alto, tenor, baritone) and be either unaccompanied or with piano accompaniment. **All finalists must provide one original copy of the score(s) for the choice repertoire. Failure to do so will result in disqualification.** Finalists are NOT required to bring copies of the required repertoire. All works with piano must be performed with piano. Sonata Mvts. 1 and 2 by Paul Creston may not be used in this round.
3. **IMPORTANT – FINALISTS WILL HAVE 20 MINUTES ON STAGE ONLY!** This timing includes walking on and off stage. If performers go over their

allotted time, they will be stopped by a proctor. There is no penalty for being stopped by the proctor.

V. General Guidelines

1. Finalists will be announced via the Acceptd application system. All communication with all competitors will be handled via Acceptd; therefore all contestants and Finalists must be able to receive email communications from Acceptd throughout the entire competition. It is the responsibility of the competitors to make sure they can receive communications from Acceptd.
2. The Winners Recital will feature the First Place Prizewinner in the High School Solo Competition and will be held on Sunday, March 8, 2020 during the North American Saxophone Alliance Biennial Conference in Tempe, AZ. Winners must be available to perform on the Winners' Recital.
3. All fees and dues are non-refundable.
4. All expenses, including lodging and transportation to and from the competition, are the sole responsibility of the contestants.
5. A minimum of 15 entries is required to hold this competition. Entry fees will be refunded if the competition is cancelled.
6. Finalists will have the opportunity to hire a NASA staff pianist. Additional details, such as costs and repertoire choice, will be made available when the application web site becomes available. You must be available on site to rehearse on Saturday, March 7, 2020 if you request a competition pianist.
7. Professional musicians will judge both the preliminary audition recordings and the live round performances. Finalists will be evaluated solely on their live round performance.
